Since The Capitol Attack, Fortune 500 Companies And Corporate Trade Groups Donated Over \$800,000 To Election Denying House Administration Subcommittee Republicans Investigating The January 6th Committee

SUMMARY: In early March, Republicans on the House Administration Subcommittee on Oversight <u>launched</u> <u>an investigation</u> into the January 6th Committee's findings. The inquiry will be headed by Rep. Barry Loudermilk (GA-11), who has "personal beef" with the January 6th Committee after it sought to investigate the tours of the Capitol that Loudermilk led on January 5, 2021. Loudermilk will be joined in the effort by Rep. Morgan Griffith (VA-9) and Rep. Greg Murphy (NC-3), both of whom voted against certifying the 2020 election after the violence on the Capitol.
