Summary: Since Trump's election victory in November 2024, he has nominated at least ten individuals to posts in his administration who have served as lobbyists. They are the following:

- Longtime lobbyist Susie Wiles was selected to serve as Trump's Chief of Staff.
- Lobbyist **Bill McGinley** was selected by Trump to serve as Counsel to the Department Of Government Efficiency.
- Lobbyist and former Rep. **Doug Collins** was selected to serve as Secretary Of Veterans Affairs.
- Lobbyist and former Rep. **Sean Duffy** was selected to serve as Secretary Of Transportation.
- Lobbyist and former Acting Attorney General **Matthew Whitaker** was selected to serve as Ambassador to NATO.
- Lobbyist and former Florida Attorney General **Pam Bondi** was selected to serve as Attorney General.
- Lobbyist **Alex Wong** was selected to serve as Deputy National Security Advisor.
- Lobbyist and former Rep. **Pete Hoekstra** was selected to serve as Ambassador To Canada.
- Lobbyist Jamieson Greer was selected to serve as U.S. Trade.
- Lobbyist **James Braid** was selected to serve as Director of the Office Of Legislative Affairs.

Last week, she addressed an influential group of donors in Las Vegas, saying, among other things, that Mr. Trump planned to reinstate some of his prior executive orders that President Biden had revoked. Ms. Wiles, 67, was registered as a lobbyist until early this year. She did not sever ties with Mercury Public Affairs, where she began working in 2022, until after she was named chief of staff on Nov. 7, said two people familiar with the timing who spoke on the condition of anonymity to discuss private matters." "Hoekstra, who chaired the House Intelligence Committee from 2004 to 2007, has been floated repeatedly over the past week as a potential CIA chief. But his lobbying record is extensive; he worked as a lobbyist for Greenberg Traurig and Dickstein Shapiro after leaving Congress in 2011, and then struck out on his own this year. The Michigan Republican, who served 18 years in the House and unsuccessfully pursued both the Michigan governorship and a Senate seat, currently heads Hoekstra Global Strategies, whose clients include Oregon-based manufacturer Columbia Helicopters and Michigan-based oil production outfit Core Energy, according to lobbying disclosure reports. In 2016, his company reported

\$68,500 in income from the two companies. In his work before that, at Greenberg Traurig and Dickstein Shapiro, Hoekstra lobbied on behalf of multiple domestic corporations, including coal giant Peabody Energy and tobacco company Lorillard Inc., as the latter went through a \$27.4 billion merger with Reynolds American."
