Late October And November 2022: Major Companies And Trade Groups Donated At Least \$307,900 To The Sedition Caucus.

Between October 20 And November 28, 2022, Fortune 500 Companies And Corporate Trade Groups, Such As Wells Fargo, Marathon Petroleum, And Verizon, Gave At Least \$307,900 To The Members Of Congress Who Voted Against Certifying the 2020 Election Results Following the Insurrection on January 6th, 2021—A Group That Has Been Dubbed The “Sedition Caucus.”
