"A now-retired federal official said he bowed to political pressure from a higher-up in the Trump administration when he reversed a key decision he had made on a 28,000-home Benson development near the San Pedro River. 'I got rolled,' said Steve Spangle, who was a top U.S. Fish and Wildlife Service official in Phoenix. A 'high-level politico" at the Interior Department pressured him through an attorney in its Solicitor's Office, Spangle told the Arizona Daily Star in a recent interview."
