SUMMARY: Rep. Marc Molinaro (NY-19) <u>voted for</u> the Republican Default Bill putting the benefits and livelihoods of thousands of his constituents, including nearly 174,000 Social Security recipients, 40,000 veterans, and 102,000 students. Rep. Molinaro <u>endorsed</u> the Republican Default Bill claiming it would "strengthen Social Security and Medicare" and "preserv[e] protections for SNAP and programs that vulnerable New Yorkers rely on."

Furthermore, a Republican-led default threatens Medicare for 3.7 million New Yorkers and Social Security for 3.6 million, while putting almost 690,000 New York veterans at risk. A Republican-led default would also threaten \$7.8 billion in SNAP and TANF assistance for New Yorkers.

Lastly, a Republican-led default threatens the quality of life and economic security of New York's 3.3 million senior citizens, the 4th largest population of seniors in the United States, with 87% relying on Social Security income and 11% being veterans.

Washington, DC - U.S. Rep. Marc Molinaro (NY-19) released the following statement on the Limit, Save, Grow Act of 2023:

The Republicans' Default Deal Would Result In An Over \$11 Billion Cut In SNAP And TANF Funding.

According To the Nonpartisan Congressional Budget Office, Republicans' Default Deal Would Impose New Work Requirements For SNAP And TANF Resulting In An Over \$11 Billion Reduction In Funding. "CBO estimates that expanding the work requirement to adults ages 50 to 55 would reduce direct spending by \$11 billion over the 2023–2033 period. [...] CBO estimates that the resulting reduction in [TANF] block grants would reduce direct spending by \$6 million over the 2023–2033 period." [CBO, 04/25/23]
