# Rep. Jen Kiggans (VA-02) Voted For And Endorsed The Republican Default Bill That Threatens The Financial, Health, And Food Security Of Her Constituents, Including 138,000 Social Security Recipients And 88,000 Veterans

**SUMMARY**: Rep. Jen Kiggans (VA-02) <u>voted for</u> the Republican Default Bill putting the benefits and livelihoods of thousands of her constituents, including over 138,000 Social Security recipients, 88,000 veterans, and 126,000 students at risk. Rep. Kiggans <u>endorsed</u> the Default Bill as <u>"slash[ing] wasteful government spending and plac[ing] America on the path to fiscal sanity.</u>"

Furthermore, the Republican-led default threatens Medicare for <u>1.6 million</u> Virginians and Social Security for nearly <u>1.6 million</u>, while putting <u>691,000</u> Virginia veterans at risk. A Republican-led default would also threaten over \$1.4 billion in <u>SNAP</u> and <u>TANF</u> assistance for Virginians.

A Republican-led default threatens the quality of life and economic security of Virginia's <u>1.3</u> million senior citizens, with <u>88% relying on Social Security income</u> and <u>19% being veterans</u>.

#### <u>The Republicans' Default Deal Would Result In An Over \$11 Billion</u> <u>Cut In SNAP And TANF Funding.</u>

According To the Nonpartisan Congressional Budget Office, Republicans' Default Deal Would Impose New Work Requirements For SNAP And TANF Resulting In An Over \$11 Billion Reduction In Funding. "CBO estimates that expanding the work requirement to adults ages 50 to 55 would reduce direct spending by \$11 billion over the 2023–2033 period. [...] CBO estimates that the resulting reduction in [TANF] block grants would reduce direct spending by \$6 million over the 2023–2033 period." [CBO, <u>04/25/23</u>]
