SUMMARY: Rep. Mike Lawler (NY-17) <u>voted for</u> the Republican Default Bill, putting the benefits and livelihoods of thousands of his constituents, including over 131,000 Social Security recipients, 21,000 veterans, and 140,000 students. Rep. Lawler <u>endorsed</u> the bill as "<u>a beginning [that] puts the President and Senate Majority Leader on notice - the days of one-party rule are over</u>."

Furthermore, a Republican-led default threatens Medicare for <u>3.7 million</u> New Yorkers and Social Security for <u>3.6 million</u>, while putting almost <u>690,000</u> New York veterans at risk. A Republican-led default would also threaten \$7.8 billion in <u>SNAP</u> and <u>TANF</u> assistance for New Yorkers.

Lastly, a Republican-led default threatens the quality of life and economic security of New York's <u>3.3 million</u> <u>senior citizens</u>, the 4th largest population of seniors in the United States, with <u>87% relying on Social Security</u> <u>income</u> and <u>11% being veterans</u>.


The Republicans' Default Deal Would Result In An Over \$11 Billion Cut In SNAP And TANF Funding.

According To the Nonpartisan Congressional Budget Office, Republicans' Default Deal Would Impose New Work Requirements For SNAP And TANF Resulting In An Over \$11 Billion Reduction In Funding. "CBO estimates that expanding the work requirement to adults ages 50 to 55 would reduce direct spending by \$11 billion over the 2023–2033 period. [...] CBO estimates that the resulting reduction in [TANF] block grants would reduce direct spending by \$6 million over the 2023–2033 period." [CBO, <u>04/25/23</u>]

The Republican-Led Default Threatens The Quality Of Life And Economic Security Of New York's 3.3 Million Senior Citizens.
