Speaker Mike Johnson Participated In A "Prayer Gathering" Organized By His Longtime Friend And One of His "Biggest Heroes," Tony Perkins — A Leading Figure In The Anti-LGBTQ Hate Movement

SUMMARY: On January 31, Speaker Mike Johnson <u>participated in</u> the Gathering for Prayer and Repentance, an event founded and organized by Tony Perkins, who Johnson has said is among his <u>"biggest heroes."</u> The longstanding president of the Family Research Council (FRC), Perkins is one of the most prominent voices in the movement against LGBTQ equality. Since 2011, his organization, the Family Research Council, has been <u>designated</u> a Southern Poverty Law Center hate group.

Once a fringe organization on the right, the Family Research Council has been elevated to newfound prominence with the Speaker's gavel in Mike Johnson's hand.

Perkins and Johnson's relationship dates back more than a quarter century, when Perkins was a legislator in the Louisiana State House, and Johnson was a law student at Louisiana State University. In 1996, Perkins served as the campaign manager for <u>rightwing juggernaut</u> <u>Woody Jenkins</u>' unsuccessful bid for the U.S. Senate. It was during this campaign that Jenkins and Perkins <u>conspired to purchase a donor list</u> from former Ku Klux Klan Grand Wizard David Duke — a transaction that Perkins <u>at one time admitted to</u> but now denies having done knowingly. Johnson has said that he met Perkins on the campaign trail.

Throughout the late 1990s, Johnson assisted Perkins with drafting legislation, including a <u>first-in-the-nation covenant marriage law</u> that limited couples' ability to get a divorce. (Johnson and his wife, Kelly, were married under this law in 1999.) As Johnson has put it, he served as Perkins' <u>"bag boy"</u> after graduating from law school. In 1997, Johnson helped Perkins found the Louisiana Family Forum, a right-wing organization dedicated to maintaining "traditional Judeo-Christian <u>"family values"</u> in public policy. Working pro bono, Johnson helped pen the group's incorporation filing and later represented the organization in lawsuits targeting abortion access and same-sex marriage. When Johnson first ran for Congress in 2016, he <u>identified himself</u> as a Louisiana Family Forum board member.

In 2002, Tony Perkins decided to run for the U.S. Senate. One of his first contributors was Mike Johnson's wife, Kelly, who <u>gave Perkins \$1,000</u>. The couple was also on hand at Perkins' kickoff event, where Mike Johnson told a reporter that he was a "big fan" of Perkins.

In 2008, Louisiana Governor Bobby Jindal <u>reconstituted the Louisiana Commission on</u> <u>Marriage and Family</u>, a panel of "experts" tasked with advising the state on family policy. Jindal <u>populated the commission</u> with members of the anti-LGBTQ religious right, including both Mike Johnson and Tony Perkins.

In 2010, the Baptist institution of higher learning Louisiana College <u>invited Mike Johnson</u> to be the inaugural dean of its Pressler School of Law. The invitation came from the school's board of trustees, on which Tony Perkins sat. Johnson struggled to raise funding for the new law school for two years. It ultimately never opened, and Johnson resigned in the fall of 2012.

Johnson then moved on to <u>found Freedom Guard</u>, his pro bono law firm. Perkins <u>was invited</u> to join the organization's board of directors. One of the group's first projects was to draft <u>model bylaws</u> for Christian churches and groups to include in their founding documents, including a statement of faith that described homosexuality as a "sexual immorality" akin to bestiality and incest.

In 2016, fourteen years after Perkins vied for federal office, Johnson threw his hat into the ring. Perkins <u>donated \$2,700</u> to Johnson's campaign, the legal maximum for personal contributions at the time. Johnson won his election in an uncompetitive House district in northern Louisiana in November of that year.

Johnson has <u>received the endorsement</u> of the Family Research Council Action PAC in every election since 2016. He is also the three-time recipient of the political action committee's <u>"True Blue" award</u>, given to members of Congress who get 100% on the group's voting scorecard.

In 2020, the Family Research Council joined several other right-wing organizations to reclassify itself as an "association of churches," a change that permits the group to hide its finances from public disclosure. The amendment to FRC's tax status drew a rebuke from <u>dozens of members of Congress</u>, who noted that the group <u>has not functionally changed</u> and remains heavily involved in politics. At the time of its change in tax status, FRC operated a multi-million-dollar war chest.



The Family Research Council Reclassified Itself As An "Association Of Churches" In 2020 In Order To Hide Its Finances From Public Disclosure, Drawing A Rebuke From Forty Members Of Congress.

In 2020, The Family Research Council Successfully Reclassified Itself As An "Association Of Churches" Allowing The Group To Stop Filing A Public Annual Return

March 2020: The Family Research Council Requested That The Internal Revenue Service Reclassify The Organization As An "Association Of Churches." "According to documents obtained via the Freedom of Information Act and given to ProPublica, the FRC filed an application to change its status to an "association of churches," a designation commonly used by groups with member churches like the Southern Baptist Convention, in March 2020. The agency approved the change a few months later." [ProPublica, <u>7/11/22</u>]

As An "Association Of Churches," The Family Research Council Is Exempt From Filing An Annual Information Return (Form 990) With The Internal Revenue Service. "Every organization exempt from federal income tax under Internal Revenue Code section 501(a) must file an annual information return except...A church, an interchurch organization of local units of a church, a convention or association of churches..." At The Time It Stopped Filing An Annual Return, The Family Research Council Operated A Multimillion-Dollar War Chest

Members Of Congress Have Called For An Investigation Into The Family Research Council's Reclassification As An Association Of Churches As The Group And Its Leadership Have Often Blurred The Line Between Its Nonpartisan And Partisan Entities

August 2022: Forty Members Of Congress Asked The Internal Revenue Service And The Treasury To Investigate Right-Wing Advocacy Groups That Had Recently Reclassified Themselves As Churches. "Forty members of Congress on Monday asked the IRS and the Treasury to investigate what the lawmakers termed an "alarming pattern" of right-wing advocacy groups registering with the tax agency as churches, a move that allows the organizations to shield themselves from some financial reporting requirements and makes it easier to avoid audits." - In Their Letter, The Lawmakers Noted That The Family Research Council Remains Actively Involved In Political Advocacy. "All section 501(c)(3) organizations, including churches, "must not devote a substantial part of their activities to attempting to influence legislation, political activity, or public policy." The FRC is primarily a political advocacy organization that is "committed to advancing faith, family, and freedom in public policy and the culture from a biblical worldview." Recently, the FRC filed amicus briefs supporting the overturning of Roe v. - The Lawmakers Also Drew Attention To The Fact That The Family Research Council Does Not Exhibit The Same Organizational Characteristics As A Religious Body. "FRC claiming to be a church strains credulity: they do not hold religious services,

do not have a congregation or affiliated congregations, and do not possess many of the other attributes of churches listed by the IRS5. FRC is one example of an alarming pattern in the last decade – right- wing advocacy groups self-identifying as "churches" and applying for and receiving church status." Tony Perkins Has Also Often Blurred The Line Between His Two Organizations, Including When Expressing Political Views. "Family Research Council Action is registered at the same address as the FRC and shares all five of the part-time employees it lists on its tax form, including Perkins...But FRC Action lists zero full-time employees on its most recent tax filing. When Perkins — who is president of both organizations — is speaking, he rarely makes a delineation about whether he is speaking as the head of the FRC or the head of Family Research Council Action...In December 2020, Perkins — reportedly a close confidant of Trump's during his presidency — signed a letter containing the false claims that state officials violated election laws and that "there is no doubt President Donald J. Trump is the lawful winner of the presidential election." The letter called on state lawmakers to appoint a new slate of electors to override the election President Joe Biden won. Louis "Woody" Jenkins Was A Longtime "Arch-Conservative" Member Of The Louisiana House Of Representatives

Jenkins Was Known As An "Arch-Conservative" In The State Legislature. "In 1978, Mr. Johnston was opposed by an arch-conservative state legislator, Woody Jenkins, who got 40 percent of the vote in a poorly financed effort." [The New York Times, <u>10/7/90</u>]

- In The Louisiana Legislature, Woody Jenkins Authored A Law Permitting Parents To Home-School Their Children In Order To Avoid Court-Mandated Bussing. Jenkins Hired A Phone Auto-Calling Service, Impact Mail And Printing, On The Advice Of David Duke. Perkins Signed The Contract With Impact Mail And Printing, And The Jenkins Campaign "Knowingly And Willfully Filed False Disclosure Reports" To Avoid Associating With Duke And Impact Publicly. "Jenkins tried to cancel the transaction with Impact Mail, but could not because Perkins had already signed a contract. Jenkins allegedly instructed Perkins to stop payment on the check to the company and "directed that Impact Mail be paid through Courtney Communications, the campaign's media firm," according to the conciliation agreement, which said Jenkins "did not want his campaign to be associated with Impact Mail." The Jenkins campaign "knowingly and willfully filed false disclosure reports" showing its media firm as the vendor of \$82,500 in services actually provided by Impact Mail, according to the FEC document. Perkins used Courtney Communications, which is run by Bob Courtney, a one-time business partner, to disguise the payment. "We didn't want any appearance that we had any connection to Duke," Perkins told the newspaper. Jenkins Claimed There Was Election Fraud And Disputed His Defeat In The Campaign. • A Senate Committee Unanimously Concluded That There Wasn't Compelling Evidence To Overturn The Election. "A Senate committee voted unanimously today to drop its inquiry into the election of Senator Mary L. Landrieu after months of partisan wrangling, the expenditure of hundreds of thousands of dollars and a foray into the roguish world of Louisiana politics...In its report to the full Senate, which is expected to ratify the recommendation, the committee stated that investigators uncovered a host of election irregularities and "isolated incidences of fraud," but no evidence compelling enough to overturn the election." Johnson earned his bachelor's degree in business administration in 1995 where he was selected to Leadership LSU and the Order of Omega Honor Society, Kappa Sigma Fraternity and served as president of the LSU Interfraternity Council." While In Law School, Mike Johnson Helped Tony Perkins Write Legislation, Including A Covenant Marriage Law

In October 2023, Tony Perkins Told A Christian News Site That He Has Known Mike Johnson For About 25 Years. "Perkins, 60, said his relationship with Johnson, 51, goes back about 25 years. The two first met while Johnson was still a law student at Louisiana State University. According to Perkins, a Republican who served in the Louisiana House of Representatives from 1996 until 2004, he and Johnson have 'worked on a number of issues and have had a personal relationship since then.'" 



Governor Steve Beshear, who had supported the project since it was unveiled in 2010, said in a written statement on Wednesday that the leaders of the project had gone back on a pledge not to discriminate in hiring." In 2015, Ark Encounter Hired Mike Johnson And His Public Interest Law Firm In Its Fight To Retain The Tourism Tax Incentives. "Working for Freedom Guard, a non-profit proclaiming a commitment to defending religious liberty, Johnson was hired by Answers in Genesis, a creationist ministry, in 2015, after the state of Kentucky rescinded an offer of tourism tax incentives for the project in Williamstown, citing discrimination against non-Christians." • Mike Johnson Founded Freedom Guard And Served As Its Chief Executive Officer And Chief Counsel. "In Louisiana and beyond, that work is being handled very effectively these days by a public interest law firm known as Freedom Guard. This not-for-profit legal organization is dedicated to defending faith and freedom through landmark litigation, strategic counsel, education initiatives, and public advocacy. The work of the organization is led by CEO and Chief Counsel Mike Johnson, a nationally recognized constitutional law attorney who is a member of the Louisiana Legislature, and who formerly served as Senior Legal Counsel and media spokesman for the Alliance Defending Freedom, and as a trustee of the Ethics and Religious Liberty Commission of the Southern Baptist Convention." Ark Encounter Eventually Won Their Case In Federal District Court After The Judge Ruled That The State Could Not Discriminate Against The Organization On The Basis Of Religion. "A federal judge ruled Monday that Kentucky officials violated the ark builders' First Amendment protections by blocking it from the sales tax tourism incentive that could have been worth up to \$18 million...A spokeswoman for Gov. Matt Bevin said Tuesday that the state has no plans to appeal, adding that they were pleased with U.S. District Judge Gregory Van Tatenhove's ruling. The Ark Encounter, being built by Christian group Answers in Genesis, is due to open in July. Van Tatenhove ruled the state's Tourism Cabinet cannot exclude the ark attraction from the incentive based on its "religious purpose and message." The state initially celebrated the project but reversed course in late 2014." [WCPO, <u>1/25/16</u>]

However, Ark Encounter Eventually Lost The Tax Incentives After A Breach Of Contract In 17. "The Ark Encounter is losing a major tax break of \$18 million for breach of contract. Weeks after the Ark Encounter celebrated its one year anniversary, the state's tourism agency pulled the plug on millions in tax breaks. The Tourism Art and Heritage Cabinet claims Answers in Genesis, the group that built the Ark, broke an incentives agreement by transferring the property to a nonprofit affiliate." [WDRB, 7/21/23]

• The Owner Of Ark Encounter, Ken Ham, Sold The Multi-Million Dollar Property To His Own Nonprofit For \$10 In What Appeared To Be An Attempt To Avoid Paying A New Safety Tax. "Not satisfied enough with winning a court battle worth \$18 million in tax rebates after convincing a judge that his for-profit business, which is actively using religion as a form of employment discrimination, he has now sold the land the theme park sits on, worth \$48 million, to his own non-profit entity, Crosswater Canyon, for \$10. You read that right, ten dollars...This allows Ham to claim his land is a non-profit and not subject to the new safety tax passed by city officials which would have collected 50 cents of every entry ticket sold. This move also worries local politicians and residents because it sets up the park to claim exemption from all other taxes as well that includes the funding of public schools." Ken Ham Quickly Sold Ark Encounter Back To His For-Profit Entity To Retain The Tax Incentives. "Faced with losing \$18 million in tax incentives, the Ark Encounter operators sold the ark property back to their for-profit entity on Monday. This will likely mean the state will restore the tax incentives for the Noah's Ark-themed attraction in Grant County, a rural county about a 45-minute drive south from Cincinnati. Kentucky halted the Ark Encounter's tax incentives last week when tourism officials determined the attraction breached its agreement with the state after its ownership changed to nonprofit. This property maneuver has happened while the Ark Encounter and city of Williamstown feud over a 50-cent safety fee." [Cincinnati Enquirer, 7/25/17]

Of those eight, Marshall Jones (D) and Mike Johnson (R) advanced to the general election which was held on December 10, 2016. Johnson subsequently defeated Jones in the general election.
