

Project 2025 Anti-CFPB Chapter Author Robert Bowes Is A Former Banker, Fan Of “Anarcho-Capitalism,” “Fedsurrection” And Election Conspiracy Theorist, And An Anti-Woke Warrior

SUMMARY: Project 2025, a radical MAGA plan to gut the federal government if a conservative wins the White House, would “[defund the Department of Justice, dismantle the FBI, break up the Department of Homeland Security and Eliminate The Departments Of Education And Commerce.](#)”

Project 2025 has also set its sights on the Consumer Financial Protection Bureau (CFPB), which has provided over [\\$20 billion](#) in compensation and relief and has benefited over [205 million](#) consumers or accounts since the Bureau’s creation in the wake of the 2008 financial crisis.

The author of Project 2025’s chapter on killing the CFPB is Robert Bowes, a former [senior Trump administration official](#) and [failed](#) regulatory agency [nominee](#) who touts a “[decadeslong career in finance](#)” at giants Chase Manhattan and Fannie Mae. Notably, these two strains in Bowes’ history crossed paths when he faced scrutiny for making up to [\\$3.2 million](#) in trades while in the Trump Department of Housing and Urban Development (HUD), including [suspiciously making five-figure bets](#) against one cruise company while pushing HUD to use its rival company’s ships as COVID-19 shelters.

In his Project 2025 chapter, Bowes calls the CFPB “[damaging](#)” and “[utterly unaccountable](#),” demands that Congress “[abolish the CFPB](#),” offers support for the payday lending industry’s pending Supreme Court case against the bureau’s constitutionality, and calls for [industry-backed](#) repeals of key CFPB anti-discrimination policies.

New Accountable.US research has revealed troubling new aspects of Bowes’ far-right political beliefs—including fringe “anarcho-capitalist” leanings, conspiracy theorizing about the Jan. 6 insurrection and the 2020 election, and highly discriminatory rhetoric—all of which would threaten core tenets of the CFPB’s mission if Bowes were ever put into a position of power:

- Bowes has repeatedly posted about or amplified Argentina’s “[anarcho-capitalist](#)” president Javier Milei, supporting Milei’s “[SLASH AND BURN](#)” anti-government efforts and liking Milei’s quote: “[Shove the state in your f**ing a**hole \[...\] I wipe my a** with the state.](#)”
- Bowes has repeatedly posted about January 6 conspiracy theories, claiming that federal authorities “[doctored J6 video evidence](#),” calling the insurrection the “[fed-surrection](#),” claiming Trump ballot removal efforts were falsely driven by Jan. 6 “[hoaxes](#),” and vocally supporting the far-right [Oath Keepers](#) and [Proud Boys](#)—whose leaders saw major Jan. 6 criminal convictions.
- Bowes claimed that Michigan Gov. Gretchen Whitmer “[collaborated with the feds to fabricate her election interfering kidnap hoax](#)” after a [right-wing militia](#) tried to kidnap her and overthrow the state government.
- Bowes, who has claimed “[Dems \[are\] planning another coup in 2024](#),” has [promoted](#) criminally-charged Stop the Steal Lawyer John Eastman, called the Georgia election case “[the get Trump hoax case](#),” and has regularly posted about election conspiracy theories including “[ballot box stuffing](#),” “[phantom voters](#),” and “[massive evidence of election fraud](#).”
- Bowes said he “[was honored](#)” to discuss “[the Georgia steal](#)” with Trump’s “[longtime friend](#)” and [convicted felon](#) Roger Stone, has [appeared](#) with Stone elsewhere, and liked Stone’s post saying the “[fight between liberals and conservatives](#)” is “[nothing less than a fight between good and evil](#).”

- Bowes, who has called himself an “[election investigator](#),” has appeared on Tim Pool’s show, which platforms “[hard-right](#)” views, to say “[President Trump beat the cheat in 2016. Well, I think he beat the cheat in 2020](#)” while [promoting](#) his [website](#) to raise funds for election conspiracy defendants in Georgia and Michigan.
- Bowes has repeatedly posted or amplified racially discriminatory material: he said the [first](#) Muslim-American U.S. Circuit judge nominee was among “[Sharia supremacists](#),” reposted Tucker Carlson’s claim that George Floyd’s story was driven by “[lies](#)” because Floyd was “[not murdered](#),” and [liked](#) a post complaining that corporate diversity increased after Black Lives Matter protests.
- Bowes has repeatedly liked insensitive posts about gender and sexuality, including one calling transgender identity “[womanface](#),” in reference to blackface; one saying the “[best thing about Republican Women](#)” is they have “[no penis](#)”; and another proclaiming “[HETEROSEXUAL PRIDE!](#)”
- Bowes’ other conspiracy-minded activity includes calling COVID-19 vaccines “[the clot shots](#),” calling Dr. Anthony Fauci a “[merchant of death](#),” and sharing a post calling climate change “[the big hoax](#).”

Bowes Wrote, That Until A Conservative President Abolishes The CFPB, Congress Should Repeal Dodd-Frank Section 1071, A Small Business Data Collection Rule Intended To Fight Discrimination That Has Been Opposed By The Banking Industry. 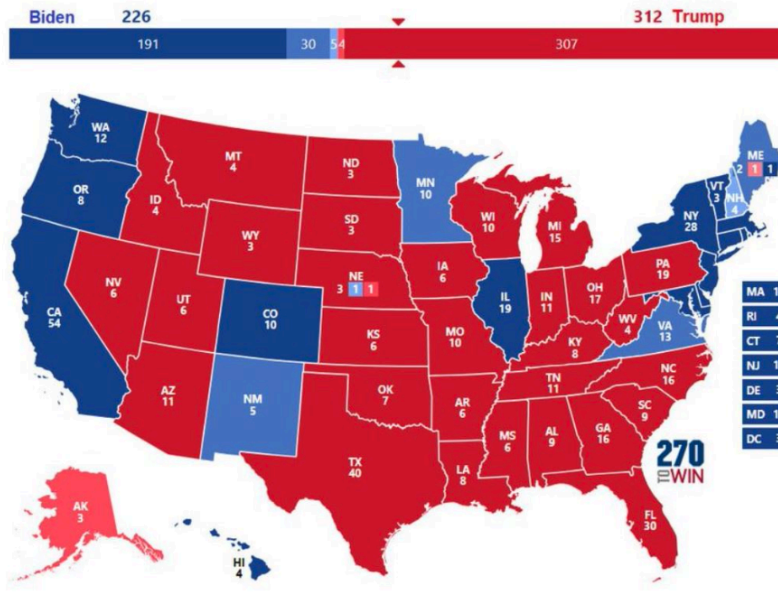

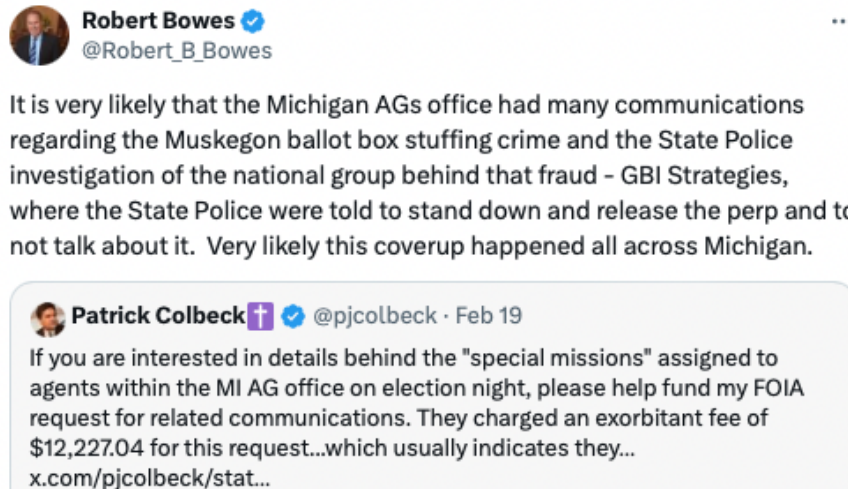


