Russ Vought—A Key Project 2025 Figure Deeply Tied To Suspicious MAGA "Nerve Center" And Far-Right Figures—Plans To Impose Extreme "Christian Nationalism" And Wage Anti-Woke War On Federal Government

SUMMARY: Russ Vought, Trump's former Office Of Management And Budget (OMB) Director, has been planning to "<u>infuse Christian nationalist ideas</u>"—which assert "<u>Christian primacy in politics and law</u>" over all other faiths and principles—in the next conservative White House, where Vought is likely to be named <u>Chief of Staff</u>.

Vought has been playing a key role as an advisor for the Radical MAGA Project 2025, which states that "freedom is defined by God, not man" and would "defund the Department of Justice, dismantle the FBI, break up the Department of Homeland Security and Eliminate The Departments Of Education And <u>Commerce</u>." Along these lines, Vought was an "<u>architect</u>" of Trump's Schedule F, an executive order to "<u>gut</u>" the federal government—and he has warned that a future administration can wield the policy "<u>through</u> <u>executive power alone</u>."

Vought has written a leading chapter in Project 2025's plan to reform the Executive Office of the President in the next conservative administration. This chapter claims that "<u>woke</u>'" federal agencies have been "<u>weaponized against the public</u>," recommends "<u>aggressive</u>" restrictions on bureaucracy, calls for "<u>fearless</u>" challenges of legal precedents, and even opposes "<u>good government</u>'" principles.

Vought's specific policy recommendations include:

- For the **Office Of The Management And Budget (OMB)**, Vought prescribes using "<u>every possible</u> tool" to "<u>impose fiscal discipline</u>," reinstating trump's political control over agencies, "<u>fearless</u>" challenges of legal precedents, opposing the "<u>good government</u>" community, and using federal contracts to resist "<u>woke</u>" corporate america.
- For the **National Security Council (NSC)**, Vought recommends increasing political control over national security policy and review of policies and personnel to restrain "<u>social engineering and</u> <u>non-defense matters, including climate change, critical race theory, manufactured extremism, and other polarizing policies</u>."
- Vought recommends vetting Council of Economic Advisers (CEA) members, who often overlap between administrations, for ideological <u>"alignment with White House policy objectives</u>" so they don't <u>"breed skepticism and distrust</u>" with the White House.
- For the **Office of Science and Technology Policy**, Vought says "the Biden Administration's climate fanaticism will need a whole-of-government unwinding" and its "woke agenda should be reversed and scrubbed from all policy manuals, guidance documents, and agendas."
- In a section on the **Council on Environmental Quality (CEQ)**, Vought recommends <u>eliminating the</u> <u>Interagency Working Group on the Social Cost of Carbon (SCC)</u>, which guides climate regulation.
- Vought recommends revoking President Biden's White House Gender Policy Council, which he claims promotes "the new woke gender ideology," and appointing a Special Assistant to the President to coordinate and lead "issues related to life and family."

Meanwhile, Vought's far-right group the Center for Renewing America (CRA) has drawn plans that explicitly mention "<u>Christian nationalism</u>" and would invoke the Insurrection Act on the first day of the next conservative administration in order to "<u>to quash protests</u>."

From its inception, CRA (originally known as the Center for American Restoration) was intended to push <u>divisive cultural issues</u>, with Vought condemning "<u>personal autonomy</u>" and tying equality and diversity to "<u>cultural Marxism</u>." Under Vought, CRA has hired prominent extremists, including former Trump Justice Department official <u>Jeffrey Clark</u>, who was <u>criminally charged</u> for his role in trying to overturn the 2020 election; disgraced FBI agent <u>Steve Friend</u>, an insurrection <u>conspiracy theorist</u> who refused to raid a dangerous Jan. 6 suspect's home; and former Trump OMB General Counsel <u>Mark Paoletta</u>, who was behind some of Trump's "<u>most divisive and legally aggressive moves</u>."

Consistent with CRA's far-right agenda, Vought has repeatedly endorsed extreme, theocratic, and anti-secular worldviews:

- In 2023, Vought was "excited" to appear on a podcast hosted by right-wing pastor Tom Ascol, who supported Uganda's <u>LGBTQ criminalization</u> law, including its <u>death penalty</u>. Vought told Ascol the country's laws must recognize "<u>only one true God</u>," warned Christians are "<u>in the crosshairs of the federal government</u>," and called the Democratic Party "<u>increasingly evil</u>" because it is "<u>intent on</u> <u>preserving a particular secular worldview</u>."
- Vought's online Christian nationalism includes claiming both parties have pushed "<u>a religion of secularism</u>" that "<u>cannot undergird a healthy society</u>," calling for "<u>political combat</u>" against Christians' enemies, and endorsing a view that it was a "<u>grave mistake</u>" to allow cultural, religious, and ideological diversity—long after Vought faced condemnation for calling Islam a "<u>deficient theology</u>."
- Vought has helped to <u>spread Jan. 6 conspiracy theories</u>, lifting up claims that leading insurrectionist Ray Epps was a federal agent and warning that federal law enforcement will charge Republicans as terrorists.
- Vought has seemed to suggest that extremist or hate groups designated by the Southern Poverty Law Center (SPLC) are actually "<u>effective groups who love America</u>," telling SPLC that his Center for Renewing America was "<u>officially offended that we have not made [its] list</u>."
- Vought has "<u>a close affiliation</u>" with and has been "<u>proud to work with</u>" William Wolfe, a former Trump
 Official and christian nationalist who has <u>argued</u> for ending sex education, overturning same-sex
 marriage, ending abortion, and has warned Christians may soon need to "<u>heed the call to arms</u>."

Russ Vought and his wife Mary Vought, who leads a major Republican political group, are deeply intertwined in the network of MAGA "<u>nerve center</u>" the Conservative Partnership Institute, a sprawling effort led by former Trump Chief of Staff Mark Meadows that is <u>drawing suspicion</u> for abusing federal tax laws:

- Vought is a <u>beneficial owner</u> of Compass Professional Inc., a for-profit "<u>spinoff</u>" of MAGA "'<u>nerve</u> <u>center</u>" the Conservative Partnership Institute (CPI). CPI <u>incubated</u> Vought's Center for Renewing America and has faced legal scrutiny for "<u>pushing the boundaries of tax law</u>" that bars tax-exempt non-profits from political activity.
- Russ Vought's <u>wife</u> Mary Vought owns PR firm Vought Strategies, which has been registered at the Voughts' previous <u>residential address</u> and has collected over <u>\$900,000</u>—nearly 100% of its federal political income—from the Senate Conservatives Fund and its <u>super PAC</u>, which Mary Vought has <u>led</u> since <u>May 2019</u>. Notably, Russ Vought's Center for Renewing America, Mary Vought's Senate Conservatives Fund, and CPI all share <u>the same address</u> at CPI's headquarters. Mary Vought has

also <u>repeatedly intersected</u> with CPI, a close "<u>partner</u>" and <u>incubator</u> of Russ Vought's Center For Renewing America.

- Russ Vought is a <u>treasurer</u> for <u>CPI network</u> group <u>America First Legal Foundation</u>, which Mary Vought praised in a <u>March 2024 article</u> for the group's <u>Jane Doe lawsuit</u> against what she called "radical" gender and racial policies in Fairfax, VA county public schools, where Mary Vought said their children <u>attend</u> school.
- In possible violation of <u>federal ethics law</u>, Vought <u>didn't disclose</u> future employment with his far-right Center for American Restoration as he was about to leave federal government—even after he <u>formed</u> the group and <u>registered</u> its website and while he used his OMB post to approve <u>a flurry of</u> <u>right-wing rule rollbacks</u> aligned with his new groups.







However, because the Department determined that this rule is a 'significant regulatory action' under Executive Order 12866, § 3(f)(4), in as much as it raises novel legal or policy issues that arise out of legal mandates, the President's priorities, or the principles set forth in an Executive Order, the Office of Management and Budget has reviewed it." The Rule, First Proposed In 2019, Erased Language That Prevented Federal Funding From Going To Health And Welfare Programs That Discriminated On The Basis Of Sexual Orientation Or Gender Identity. "Previously, a federal regulation expressly prohibited health and welfare programs receiving federal funding from discriminating on the basis of sexual orientation and gender identity. But the administration's new rule, first proposed in 2019, erases this language. It also deletes a requirement that recipients recognize the marriages of same-sex couples, replacing it with a generic statement that the US Department of Health and Human Services will respect Supreme Court decisions." According to OMB, the purpose for the proposed revisions are 'to align with Executive Orders (E.O.) 13798 'Promoting Free Speech and Religious Liberty' and E.O. 13864 'Improving Free Inquiry, Transparency, and Accountability at Colleges and Universities.' These Executive Orders advise agencies on the requirements of religious liberty laws, including those laws that apply to grants, and set forth a policy of free inquiry at institutions receiving Federal grants [...]" [Federal Register, 01/12/21]




