Project 2025 Intends To Weaponize The Federal Government By Strengthening A Future Conservative President's Power — Insisting On Loyalty To The President And The Project 2025 Agenda– Effectively Subverting The Will Of The People

SUMMARY: The far right's agenda to massively strengthen a possible future conservative president's power is omnipresent throughout Project 2025's manifesto, Mandate for Leadership. It insists on loyalty to the president and Project 2025's agenda and effectively subverts the will of the people.

Policy proposals in the <u>Heritage Foundation-backed transition project</u> manifesto that clearly demonstrate its attempt to weaponize the federal government include:

- **Project 2025 intends to radically weaken the FBI**, demoting it within the DOJ, making it subject to more political appointees, and terminating "major active FBI investigations" that are "contrary to the national interest."
- The Project 2025 manifesto also calls on the next conservative administration to reevaluate its relationship with the news media, suggesting that the White House Press Corps might not be given office space in the White House and that the White House Correspondents Association might not be the best-coordinating body for the press corps. Project 2025 also encourages the Office of Communications leadership team to "work together closely to drive the national narrative about the White House."
- **Project 2025 embraces a strong unitary executive theory**, calling the federal government "a behemoth, weaponized against American citizens and conservative values" that conservatives intend to reverse to further empower a conservative president. It also instates federal government employees who "will be above all loyal to the president and the constitution" and policies that would strip federal agencies of long-standing decision-making power.
- Project 2025's plans for the Department of Homeland Security (DHS) include expanding the number of political appointees at DHS and giving them more power while simultaneously reducing congressional oversight and decertifying the labor union to require employee conformity.

By strengthening the president, demanding unfettered loyalty, reducing Congressional oversight, requiring conformity among federal agency employees, demoting and controlling the FBI, and tightening its grip on the press corps to drive the national narrative about the White House, **Project 2025 is crystal clear about the far-right's commitment to weaponizing the federal government to serve its extreme agenda.**

In October 2019, President Donald Trump "Signed An Executive Order Requiring Federal Agencies To Identify And Propose Offsets Whenever They Propose An Action That Increases Mandatory Spending," A Requirement Known As Administrative Pay-As-You-Go (PAYGO). "Last week, President Trump signed an executive order requiring federal agencies to identify and propose offsets whenever they propose an action that increases mandatory spending. This requirement, known as 'administrative Pay-As-You-Go (PAYGO),' is similar to statutory PAYGO that Congress has operated under at various times over the past three decades. Administrative PAYGO was put in place by the Office of Management and Budget (OMB) in 2005. However, in another similarity to Congress's PAYGO rule, administrative PAYGO has been frequently waived or outright ignored since its enactment. In 2019, The Heritage Foundation Advocated For "Pay-As-You-Go," Or PAYGO, Claiming It "Could Prevent Billions Of Dollars In Debt-Financed Spending." "All this makes the latest executive order signed by President Donald Trump so necessary. If federal agencies and future administrations stick to the rule, it could prevent billions of dollars in debt-financed spending. The rule, which builds off a less-binding memo issued in 2005, requires the federal government to cover the cost of agency decisions that would increase spending. The Heritage Foundation Said Administrative PAYGO Would Create Consequences For Federal Agencies When They Redesign Programs To Make Them More Expensive After Congress Has Passed

Budgetary Laws Allowing The Agencies To Spend "Such Sums As May Be Necessary." "After all, Congress is supposed to make spending decisions through legislation, and the executive branch merely puts those laws into action. How then would federal agencies have the ability to raise or cut federal spending? This dysfunction is a result of two types of congressional irresponsibility. First, Congress has placed larger and larger amounts of federal spending into the 'mandatory' category. Such programs do not require annual spending authorizations, and are able to avoid many budgetary restraints even on the rare occasions when Congress bothers to pass a budget. Autopilot programs, which include Social Security, Medicare, and Medicaid, are the driving force behind the rapid growth of federal spending. Second, Congress has delegated more and more decision-making power to agencies. Laws that create mandatory programs often contain language allowing federal agencies to spend 'such sums as may be necessary' to carry out a directive, which almost has the effect of giving bureaucrats a blank check. If a law provides an agency with significant leeway in terms of designing and changing programs, the agency can re-design the program later to make it more expensive with few or no consequences. "An Aggressive Approach to Senate-Confirmed Leadership Positions. While Senate confirmation is a constitutionally necessary requirement for appointing agency leadership, the next Administration may need to take a novel approach to the confirmations process to ensure an adequate and rapid transition. For example, the next Administration arguably should place its nominees for key positions into similar positions as 'actings' (for example, putting in a person to serve as the Senior Official Performing the Duties of the Commissioner of CBP while that person is going through the confirmation process to direct ICE or become the Secretary). This
