- **American Stewards Of Liberty Is A 501c3.** “American Stewards Of Liberty” is a 501(c)(3) non-profit educational organization that was formed through the merger of the American Land Foundation(ALF) and Stewards of the Range (Stewards) in 2009.” [American Stewards of Liberty, accessed [03/24/21](#)]

IRS Rules Say That 501(c)(3) Groups Are “Absolutely Prohibited” From Participating In Political Campaigns. “Under the Internal Revenue Code, all section 501(c)(3) organizations are absolutely prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for elective public office.” [IRS, accessed [08/22/24](#)]

- **Contributing To A Political Campaign Includes Making Written Statements In Opposition To Any Candidate For Public Office.** “Contributions to political campaign funds or public statements of position (verbal or written) made on behalf of the organization in favor of or in opposition to any candidate for public office clearly violate the prohibition against political campaign activity. Violating this prohibition may result in denial or revocation of tax-exempt status and the imposition of certain excise taxes.” [IRS, accessed [08/22/24](#)]
