### Alaska Governor Mike Dunleavy Is Using Taxpayer Dollars To Fund A 501(c)(4) To Engage In A Campaign To Oppose The Biden Administration's Conservation Policies In Alaska.

**SUMMARY:** In a highly unusual arrangement, Alaska Governor Mike Dunleavy has directed as much as \$2 million in taxpayer dollars to a 501(c)(4) group to engage in a campaign to oppose the Biden Administration's conservation efforts in Alaska.

A 501(c)(4) group is unlike a normal 501(c)(3) nonprofit because it is allowed to engage in political activities, including funding independent expenditure (IE) campaigns supporting particular candidates. Though Voice does not appear to have done this, it would be free to do so in the future.

The small 501(c)(4) group was quietly started in 2015 to advocate for issues relevant to Alaska's Arctic north slope. But after President Biden was elected, the group received \$1 million through budget requests from Alaska Governor Mike Dunleavy "to ensure the development of North Slope Natural Resources." Dunleavy has an usually close relationship with the group- he announced a vague "Joint Effort" with the group in 2021 and has attended at least one of the group's board meetings.

Since receiving an influx of Alaska taxpayer funding, Voice's spokesperson has been interviewed on Fox News and CNN disparaging the Biden Administration's policies, highlighted in nearly a dozen press releases from Alaska's US Senators, and quoted extensively in news interviews without criticism or mention that he is a state-funded actor.

Voice's board includes representatives from two dozen villages, corporations, and other groups ostensibly to advocate for the "majority consensus" of Alaska Natives in the Arctic. But the group excludes key Alaska Native constituencies that oppose oil development, like the regional tribal government and the village closest to the controversial Willow project.

Voice of the Arctic's spokesperson is Nagruk Harcharek. On social media, he sympathizes with extreme right-wing commentators and climate skeptics. He retweeted a post from Jordan Peterson accusing President Biden of being a"fool with a juvenile delinquent for a son."

Before an influx of state grants, Voice was "largely funded" by The Arctic Slope Regional Corporation (ASRC), one of the largest privately held companies in the United States. This company has two seats on Voice's board and has spent millions of dollars lobbying to open up the Arctic National Wildlife Refuge to oil development. After Trump opened ANWR to development, ASRC sold drilling rights to Chevron and BP for \$22.5 million.

The Arctic Slope Regional Corporation Sold Leases To BP And Chevron For \$22 Million After Congress Opened Up ANWR To Oil And Gas Drilling In 2017. "The Alaska Native regional corporation for the North Slope collected \$22.5 million from a pair of oil companies after Congress opened the Arctic National Wildlife Refuge's coastal plain to drilling in 2017, according to corporate documents. Arctic Slope Regional Corp., whose 13,000 Alaska Native shareholders own the oil rights to 140 square miles along the coastal plain, has long been one of the most aggressive advocates for opening the refuge to oil development. The payment, referenced in ASRC's latest annual report, underscores just how much the corporation had to gain from the congressional action.
