

## Trump “Border Czar” Thomas Homan—An Architect Of Zero Tolerance Family Separation—Leads Tax-Exempt Nonprofit That Pushes Homan’s Political Activity And Runs Trump-Backed Consulting Firm That Has Landed “Tens Of Millions Of Dollars Of Federal Contracts” For Industry Clients

**SUMMARY:** President-elect Trump has selected Thomas Homan—former [acting director of U.S. Immigration And Customs Enforcement \(ICE\)](#) during the first Trump administration—as “[border czar](#),” a role that doesn’t require Senate confirmation. Homan is notorious for being one of the “[architects](#)” of Trump’s zero tolerance family separation policy, which resulted in over [5,500 child separations](#). By November 2024, over [1,400 children](#) were still not confirmed to have been reunited with their parents.

Accountable.US has found that Homan’s role as border czar could conflict with his private consulting, which touts Trump’s endorsement while claiming it has secured “tens of millions of dollars of federal contracts” for his homeland security industry firm clients.

- Homan [founded](#) Homeland Strategic Consulting LLC, a private consulting firm which touts [Trump’s endorsement](#), claims to have secured “[tens of millions of dollars of federal contracts](#)” for clients, and has taken over [\\$83,000](#) from Jim Lamon, a failed U.S. Senate candidate who was indicted alongside Trump lawyers [Rudy Giuliani and John Eastman](#) in Arizona’s [fake electors case](#).
- Homan is also a [strategic advisor](#) for the Government Technology & Services Coalition (GTSC), a homeland security industry group of “[mid-sized company CEOs](#).” Homan is also on the [editorial board](#) of GTSC’s industry publication, [Homeland Security Today](#).

Accountable.US has also found that Homan’s far-right nonprofit group Border911 is possibly violating its tax-exempt status by promoting Homan’s political activity—including a keynote role at a state Republican party convention that sold tickets to a VIP reception featuring Homan:

- Homan is [President and CEO](#) of Border911, a far-right 501(c)(3) nonprofit that claims to fight a “[historic illegal alien crisis](#)” and that the U.S. is under “[attack from the inside](#).” In possible violation of its tax-exempt status, Border911 was [promoting](#) Homan’s appearances at Republican political events as of December 2024. This includes a state party convention that sold tickets to a [VIP reception](#) featuring Homan and a Women’s International Republican Club gala in New York City.
  - Additionally, Border911 held a sold out fundraiser in April 2024 at Trump’s Mar-A-Lago estate, with Trump confirmed to appear at the event and a \$100,000 “[presidential](#)” sponsorship tier.

“Homan was the face of the Trump administration's crackdown on immigration during his tenure as acting director of ICE from January 2017 to June 2018. During that time, he often appeared at White House press briefings to defend his agents' arrests of undocumented immigrants and call for stronger enforcement, according to CNN, and applauded Trump for ‘taking the shackles off’ ICE by allowing agents to make a broader range of arrests. Notably, Homan was one of the architects behind its controversial family separation policy. More than 5,500 children of immigrants were separated from their parents at the U.S.-Mexico border in 2018 under the administration's short-lived ‘Zero Tolerance’ policy. 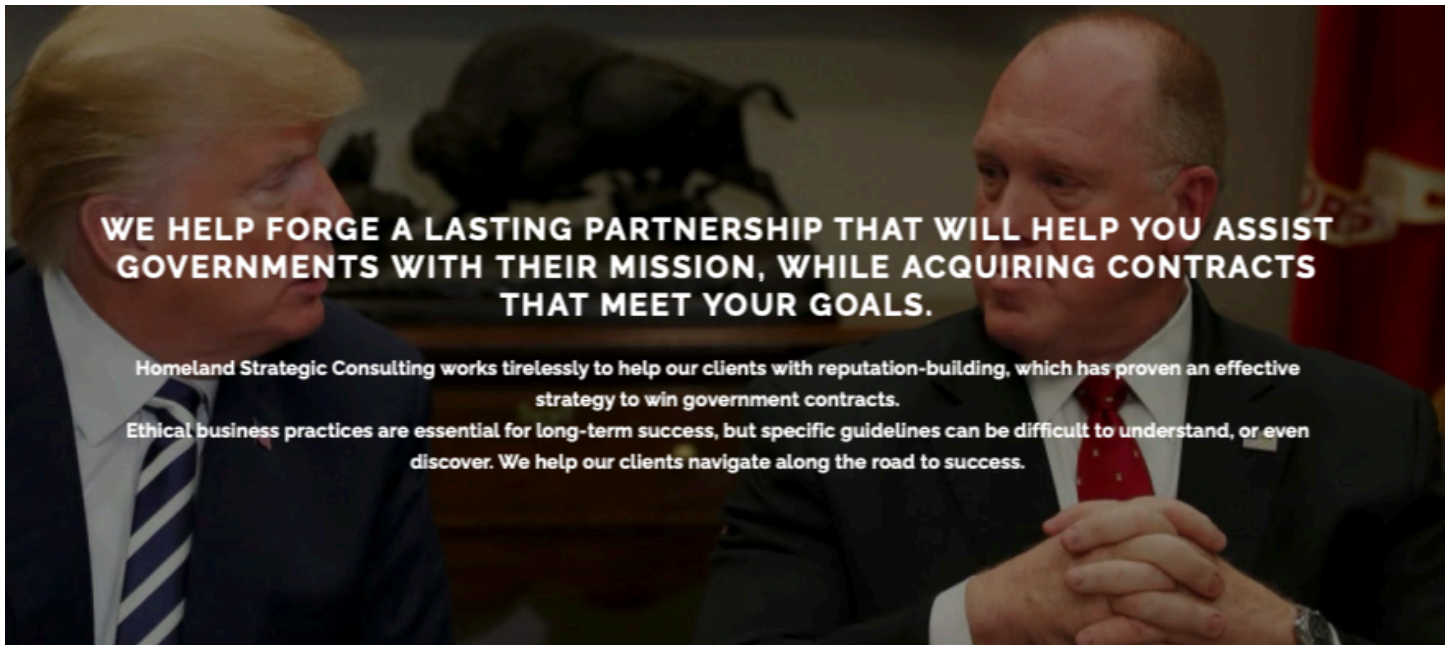

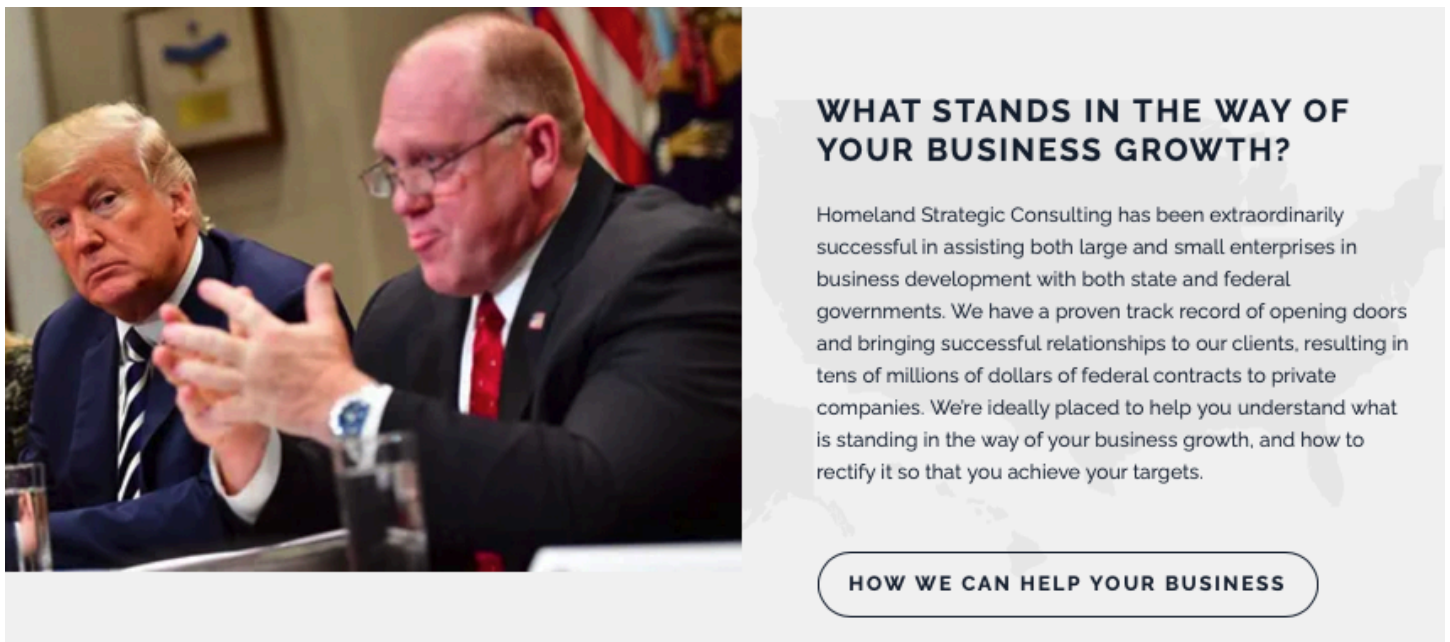

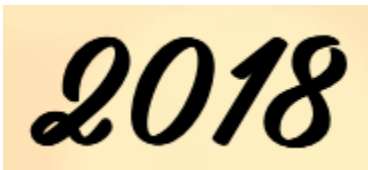
