

One Nation, A Corporate Backed Group, Pushing To Extend The Trump Tax Scam

Summary: In June 2025, One Nation—a dark money group that [wants to extend](#) the 2017 Trump tax scam and which was once responsible for the ["largest ever dark money contribution"](#) to a super PAC— [launched a \\$10 million ad campaign](#) to boost the Republican reconciliation package. As part of its campaign, One Nation [released a 30-second ad](#) urging Sen. Jon Ossoff (D-GA) to vote for the bill.

The bill, however, would cut Medicaid and throw 16 million people off health care and raise costs for working families all to pay for more tax cuts for the very wealthy.

It is no surprise that One Nation is composed of numerous big-business lobbyists, something not advertised in its attack ads. Several of its operatives include:

- One Nation [president & CEO Steven Law](#) [previously served](#) as the deputy labor secretary under George W. Bush before serving as the U.S. Chamber of Commerce's chief legal officer where he [helped the group defeat](#) legislation [aimed](#) at helping workers to form unions.
- Board member **Kenneth Cole** is [a former Pfizer and U.S. Chamber lobbyist](#) who lobbied on issues pertaining to lowering the costs of prescription drugs.

Meanwhile, One Nation has received over \$4.4 million from business and conservative-aligned groups since 2020. This [includes a \\$3 million contribution](#) from the Leonard Leo-linked Concord Fund in 2022. Meanwhile, One Nation [funneled](#) a staggering \$63.5 million to the Senate Leadership Fund during the 2024 election cycle.

And although One Nation is not required to disclose donors, notable donors in the past have included late-billionaire and casino mogul [Sheldon Adelson](#), oil refinery company [Andeavor](#), and the [American Petroleum Institute](#), which together contributed **upwards of \$13 million from 2016 to 2019**.

Finally, One Nation [shares an address](#) with that of [law firm Holtzman Vogel PLLC](#), a firm run by longtime Republican operative and ["dark money" superlawyer](#) [Jill Holtzman Vogel](#), who [represented](#) some of the largest conservative super PACs and dark money groups including Koch Groups and Karl Rove's American Crossroads.

The Ad Buys Are Part Of A \$10 Million Ad Campaign To Boost The Chances Of The Reconciliation Package Passing, And Is Slated To Run On Cable And Digital Platforms Around The Beltway And In Georgia. "The spot is running on cable, broadcast and digital in Georgia. One Nation is also undertaking a texting campaign to supplement the ad effort. One Nation is also running an ad, airing on cable and digital in D.C., which hails the reconciliation bill as a joint effort between Thune and President Donald Trump to avoid 'the largest tax hike in history.'" Cole Was Added To One Nation At The End Of 2019 After He Served On The U.S. Chamber Board Of Directors And Lobbied On Behalf Of Pharma Giant Pfizer. "ONE NATION, ONE of the dark-money groups spending the most to back Republican candidates for Senate, added a former Pfizer lobbyist and U.S. Chamber of Commerce board member to its board of directors at the end of 2019. One Nation has spent \$1.7

million already this year on ads praising the efforts of Republican senators, including the push for lower drug prices, a cause both Pfizer and the Chamber have lobbied against." [The Intercept, [04/14/20](#)]

While Serving As Pfizer Senior VP Of Government Relations From 2010 To 2018, He Lobbied On Issues Pertaining To Drug Pricing And Shortages And Served On The Chamber's Board, Which Also Opposed Legislative Efforts To Lower Drug Prices. "Cole lobbied on behalf of Pfizer as senior vice president of government relations from 2010 to February 2018, on issues including drug pricing and drug shortages. Pfizer has placed the blame for high drug prices on health care providers and insurers, while it has fought recent legislative efforts aimed at reducing drug prices. Since at least 2014, Cole has also served on the board for the Chamber of Commerce, which has similarly opposed legislative efforts to cut drug costs or allow the government to fine companies for inflating prices." Although One Nation Is Not Required To Disclose Its Donors, Other Notable Donors Have Included Late-Billionaire And Casino Mogul Sheldon Adelson, Oil Refinery Andeavor, And The American Petroleum Institute, Contributing Upwards Of \$13 Million From 2016 To 2019.

One Nation Has Also Received At Least \$10 Million From Late-Billionaire And Casino Mogul Sheldon Adelson, \$2 Million From Andeavor, One Of The Country's Largest Oil Refineries, And Over \$1 Million From The American Petroleum Institute,

August 2016: The Guardian Revealed Late-Billionaire And Casino Mogul Sheldon Adelson Contributed At Least \$10 Million To One Nation, Which Spent At Least \$16 Million On Ads In Several Key Senate Races During The 2016 Election. "The Guardian can reveal that the casino billionaire Sheldon Adelson, who is said by well-placed sources to be worried about losing control of Congress, met Trump in New York last week. [...] Two other GOP operatives familiar with Adelson told the Guardian he had given \$10m to One Nation, a group run by Steven Law, once a top aide to Senate majority leader Mitch McConnell. In Both 2016 And 2017, Andeavor—One Of America's Largest Oil Refineries—Contributed \$1 Million To One Nation, Per Voluntary Political Disclosures On Its Website. "One of the country's largest oil refiners,

Andeavor, contributed \$1 million in both 2016 and 2017 to One Nation, a dark money group with close ties to Senate Majority Leader Mitch McConnell (R-KY), according to voluntary disclosures on the company's website. Since One Nation is not required to disclose its contributors, Andeavor's disclosure of its contributions makes it one of the only known donors to the politically active nonprofit."  "Andeavor's contributions may have been used to support One Nation's efforts to influence elections. On the webpage where Andeavor voluntarily discloses information about its political and advocacy contributions, the oil refiner acknowledges that some portion of its contributions to groups like One Nation 'may be used for the purposes of lobbying or political expenditures.' A spokesperson for Andeavor told the Texas Observer in April 2018 that since it 'operates in a highly regulated and often politicized environment,' the company believes it has a responsibility to 'advocate for sound energy policies and actively engage in the political process to ensure we continue to operate in a healthy business environment.'" Holtzman Vogel Became “One Of The Premiere Legal Shops” For Dark Money Groups Following The 2010 Citizens United Decision Allowing Unlimited Independent Political Spending. “Those groups took off in the wake of the Supreme Court’s 2010 Citizens United decision, which found individuals, corporations and unions could spend unlimited sums on politics as long as they did so independently of campaigns and parties.
