# To Date, Every Single One Of Trump's Judicial Nominees, When Asked The Question, Has Refused To State Directly That Trump Lost The 2020 Presidential Election

**SUMMARY:** As of July 21, 2025, ten judicial nominees have submitted responses to questions for the record from the Senate Judiciary Committee. Every one of them has declined to answer "yes" when asked whether President Trump lost the 2020 presidential election. Instead, the nominees have sidestepped the question entirely and simply stated that President Biden was certified as the winner.

Some nominees have also argued it would be inappropriate to answer the question as their response "could be taken as opining on the broader political or policy debate regarding the conduct of the 2020 presidential election or on statements by any political figure"—seemingly entertaining the idea that President Trump's lies surrounding that election should hold the same weight as objective fact.
