

# Paramount Forked Out Nearly \$12,000 For Brendan Carr To Attend The Kennedy Center Honors As Paramount's Merger With Skydance Was Pending Before The FCC

**SUMMARY:** In early December 2024, incoming FCC commissioner and Project 2025 contributor Brendan Carr <u>accepted two tickets</u>—worth \$11,724—to attend the Kennedy Center Honors Gala & Reception. The donor of the pricey tickets was Paramount, whose pending merger with the entertainment company Skydance was awaiting Carr's approval. In July 2025, Carr <u>voted</u> to approve the merger.

Carr had also <u>attended</u> the Kennedy Center Honors on Paramount's dime in December 2023, around the time that *The New York Times* <u>broke news</u> that Shari Redstone was looking to sell her controlling stake in National Amusements, Paramount's parent company, to Skydance.

Paramount's generous gift to Carr came amid President-elect Trump's \$10 billion lawsuit against CBS, a division of Paramount, over allegations that the news program "60 Minutes" had edited an interview with Kamala Harris to tip the scales in her favor in the 2024 presidential election.

At the 2024 Kennedy Center Honors, Carr <u>reportedly told</u> Paramount executives that they would have to make concessions to appease Trump, who was still roiled by the Harris interview, for Skydance acquisition to be approved. In early July, Paramount settled with President Trump and agreed to pay him \$16 million. By the end of the month, the FCC, under Carr's leadership, had approved Skydance's acquisition of Paramount and its subsidiaries.

Carr <u>defended</u> the timing of the payout and merger, claiming the process "ran normal course."

### Skydance Agreed To Merge With Paramount For \$8 Billion In July 2024, Pending FCC Approval

July 2024: Skydance Agreed To Merge With Paramount For \$8 Billion. "Paramount Global has agreed to merge with Skydance, capping off a monthslong negotiation, in a deal that would see the Redstone family step away from control of the storied movie studio and media company. Paramount's special committee signed off on the merger Sunday, days after Shari Redstone's National Amusements, the controlling shareholder of Paramount, once again reached a preliminary agreement with Skydance, the production company known for "Top Gun: Maverick." A similar deal had weeks earlier been stopped in its tracks. The latest iteration of the deal will see the buying consortium, which includes private equity firms RedBird Capital Partners and KKR, invest more than \$8 billion into Paramount and to acquire National Amusements. The deal gives National Amusements an enterprise value of \$2.4 billion, which includes \$1.75 billion in equity." [CNBC, 7/8/24]



#### The Skydance-Paramount Merger Faced An Uncertain Future After Then-Candidate Donald Trump Sued CBS, A Division Of Paramount

October 31, 2024: Then-Candidate Trump Sued CBS For \$10 Billion, Alleging That "60 Minutes" Had Edited An Earlier Interview With Kamala Harris In Order To "Tip The Scales" Of The Upcoming Presidential Election In Her Favor. "Former President Donald Trump filed a lawsuit Thursday against CBS, demanding \$10 billion in damages over the network's '60 Minutes' interview with Vice President Kamala Harris. The suit was immediately ridiculed by First Amendment attorneys, who called it 'frivolous and dangerous.' In the complaint filed in US District Court in the Northern District of Texas, Trump's legal counsel claimed CBS' '60 Minutes' interview with Harris and the associated programming were "partisan and unlawful acts of election and voter interference" intended to 'mislead the public and attempt to tip the scales' of the presidential election in her favor. [...] Trump has repeatedly claimed that the show's interview with Harris was grossly mis-edited by CBS at the direction of the campaign, and he has called for the network to 'lose its license.'" **November 6, 2024: President Trump Won The 2024 Presidential Election.** "Former President Donald Trump will return to the White House, according to a race call by the Associated Press. Trump won the key states of Wisconsin and Pennsylvania, with a combined 29 electoral votes to clinch the 270 necessary to win the presidency. - Before Becoming Chairman Of The FCC, Carr Served As The Senior Republican Commissioner And As FCC's General Counsel. "Brendan Carr is the Chairman of the Federal Communications Commission. He previously served as the senior Republican Commissioner and as the FCC's General Counsel. Nominated by both President Trump and President Biden, Carr has been confirmed unanimously by the Senate three times." [FCC, accessed 9/24/25]
- Carr Joined The FCC As A Staffer In 2012, Then Served As A Legal Adviser To Then-Commissioner Ajit Pai From 2014 To 2017, And Was Appointed As An FCC Chair By Trump In 2017 And Biden In 2023. "Carr's appointment to lead the FCC marked the culmination of what is a 13-year tenure at the agency. The 46-year-old began at the commission as a staffer in 2012, then served as a legal adviser to then-FCC Commissioner Ajit Pai from 2014 to 2017. When Trump appointed Pai to serve as FCC chair in January 2017, Carr became the commission's general counsel. Carr was then nominated to a six-year term as commissioner by Trump in June 2017, with the Senate confirming him in August. "The media mogul Shari Redstone is in talks to sell a controlling stake in National Amusements, the parent company of the sprawling news and entertainment empire that includes the Paramount movie studio, CBS and MTV, according to three people familiar with the talks. In recent weeks, National Amusements has held talks with Skydance, the media and entertainment company founded by David Ellison, who is the son of the billionaire founder of Oracle, Larry Ellison. ## At The 2024 Kennedy Center Honors, Carr Reportedly Warned Paramount That They Would Have To Make Concessions In Order For The Skydance-Paramount Merger To Move Forward

At A Reception Following The Taping Of The Kennedy Center Honors, Carr Gave Paramount Executives A Warning That Trump's Dissatisfaction With CBS Would Require Paramount To Make Concessions. "It's become clear to executives at both companies that Trump's dissatisfaction with CBS News will make the review tougher than they anticipated, and that they'll likely need to offer concessions to win approval, people familiar with the situation said. Incoming Federal Communications Commission Chairman Brendan Carr gave Paramount executives a warning to that effect at a reception late last year following the taping of the Kennedy Center honors in Washington, according to people familiar with the exchange, and he has echoed the message in public remarks." million, the company announced late Tuesday. CBS News' parent company worked with a mediator to resolve the lawsuit. Under the agreement, \$16 million will be allocated to Mr. Trump's future presidential library and the plaintiffs' fees and costs. Neither Mr. Trump nor his co-plantiff, Texas Rep. Carr Defended The Timing Of The Paramount And Skydance Merger Approval, Claiming The Process "Ran Normal Course." "Brendan Carr defended the timing of federal approval for the merger of Paramount Global and Skydance Media, with the Federal Communications Commission chair saying the process 'ran normal course' – while also celebrating the Trump Administration's influence on the national media landscape and suggesting that 'consequences' would be felt far into the future." Carr Claimed The Perception That The Merger Approval Came Quickly After Paramount Settled The President's Lawsuit Was "Misinformation." "Carr appeared Sunday on Fox News' "Media Buzz" with host Howard Kurtz, who grilled the Trump appointee on how 'quickly' the merger was approved after Paramount settled the president's "60 Minutes" lawsuit for \$16 million – and CBS effectively canceled 'The Late Show With Stephen Colbert.' [...] Carr chalked that perception up to 'a lot of misinformation out there,' and pushed back on the notion that the timing was rushed. 'Our review here followed our very standard practice at the FCC,' Carr said. 'In fact, the timing was right in the wheelhouse of when we ordinarily approve these types of transactions or at least reach a final decision both at this administration and the last administration as well. ## Brendan Carr Faced Controversy For His Role In Project 2025, Writing The FCC Chapter While Working As A Commissioner

Project 2025 Was An Extensive Outline Of Policy Proposals To Expand Presidential Power And Impose Conservative Policies In A Future Presidential Administration, Which Trump's Second Term Has Begun To Implement. "It is a 900-page policy 'wish list', a set of proposals that would expand presidential power and impose an ultra-conservative social vision. During his campaign, Donald Trump repeatedly disavowed Project 2025, after a backlash over some of its more radical ideas. But he has nominated several of its authors to fill key government positions, and many of his initial executive orders closely follow proposals outlined in the document." [BBC, 2/13/25]



Brendan Carr Wrote The FCC Chapter Of Project 2025, In Which He Called For The Promotion Of Free Speech, An End To A Legal Shield Protecting Social Media Companies' Content Moderation, And For Tech Subsidies To Broadband Internet Access In Rural Areas. "In 2022, a right-leaning think tank asked Mr. Carr to write the chapter on the F.C.C. for Project 2025, a conservative policy blueprint for reshaping the federal government. In the chapter, Mr. Carr called for the promotion of free speech, as well as the end of a legal shield that protects social media companies for their decisions on content moderation, known as Section 230. He also argued that tech companies should contribute to a federal subsidy for broadband internet in rural areas." [New York Times, 9/24/25]
