Mooty is the son of lawyer and fossil fuel lobbyist Harold Dean Mooty Jr., who lobbied for Petroleum Convenience Marketers of Alabama.

Mooty Represented Healthcare Clients In Malpractice Or Civil Rights Violations Lawsuits

Mooty Once Represented The Doctor Of A Jailhouse Accused Of Negligence After An Inmate's Death

A Plaintiff Representing The Estate Of A Woman Who Died While Incarcerated In Madison County Jail Sued Defendants For Negligence. "Plaintiff, Robert Elliott, commenced this action in his representative capacity as personal representative of the Estate of Nikki Listau, deceased, who died while she was incarcerated in the Madison County, Alabama, Jail. Plaintiff's Second Amended Complaint asserts claims against eighteen defendants: [...] The second claim, for negligence and/or wantonness under Alabama law, is asserted against defendant ACH, as well as against all individual defendants who were employed by ACH" [Northern District of Alabama, Elliott v. Madison County, Opinion, filed 5/9/15]

• The Inmate Died After Falling Off Her Bunk In A Medical Watch Cell. "At 11:19a.m., Listau was found in her cell, completely unresponsive. Emergency personnel were contacted, and Listau was



transported to the hospital, where she died the following day, March 12. An autopsy revealed that Listau died from severe blunt force injuries, including a broken left femur and multiple rib fractures. According to Second Amended Complaint, 'Listau most likely suffered these injuries as a result of one or more falls, presumably from her bunk, while in her medical watch cell at the jail.'"
